Owens Corning Limited Warranty for Atticat® Canada Machine

LIMITED WARRANTY

Owens Corning Insulation Systems, LLC ("Owens Corning") warrants its Atticat^{*} Professional Loosefill Machine ("Atticat^{*} Machine") as provided herein to the original consumer purchaser ("Purchaser"). Owens Corning, subject to the conditions and limitations listed herein, warrants that the Atticat^{*} Machine shall be free from any defect in material and workmanship for a period of twelve (12) months. The warranty period commences on the date of purchase by the Purchaser. This warranty applies only to Owens Corning's equipment, under use and service in accordance with Owens Corning's written instructions and recommendations for installation, operation, maintenance and service of the Atticat^{*} Machine and components. In addition to purchasing the Atticat^{*} Machine, the Purchaser must also complete and return to Owens Corning the Limited Warranty Registration Card that is attached to this form within ninety (90) days from the date of purchase.

ANY IMPROPER USE, OPERATION BEYOND CAPACITY, USE OF ANY MATERIAL THAT IS NOT OWENS CORNING ATTICAT BRAND FIBERGLASS LOOSEFILL INSULATION PRODUCT OR SUBSTITUTION OR USE OF PARTS NOT APPROVED BY OWENS CORNING, OR ANY ALTERATION OR REPAIR BY OTHERS NOT AUTHORIZED BY OWENS CORNING SHALL VOID THIS WARRANTY.

REMEDY

Should the Atticat Machine be other than as warranted during the applicable warranty period, Owens Corning, at its sole option, will repair or replace the Atticat Machine or the defective components of the Atticat Machine as well as any other components which must also be repaired or replaced in order to properly repair or replace the Atticat Machine or defective components. The Owens Corning obligation to pay, however, shall be subject to these limits:

Maximum repair or replacement cost to Owens Corning shall be the replacement cost of the Atticat Machine.

The replacement described above, or at the option of Owens Corning, its monetary equivalent, will be the only remedy available to the Purchaser for the defective Atticat Machine and defective components of the Atticat Machine.

WHAT IS NOT COVERED

This warranty does not apply to and Owens Corning shall not be liable for any cause not expressly covered herein. This warranty does not cover any problems with non-defective products caused by conditions or handling beyond our control. Some examples of conditions not covered by this warranty include failures or defects in the Atticat Machine or components thereof caused by:

- Causes beyond normal and proper use including, but not limited to: acts of God, war or terrorism, fire, flood, wind or other weather damage, or exposure to chemicals or the environment.
- Failure to strictly follow Owens Corning's written instructions and recommendations for the installation, operation, maintenance and service of the Atticat' Machine and components.
- Non-manufacturing defects, including but not limited to improper maintenance, neglect, accident, casualty, vandalism or misuse of the Atticat' Loosefill Insulation or any other cause that disturbs or disrupts the Atticat' Loosefill Insulation as installed.

LIMITATIONS ON COVERAGE

ANY IMPLIED WARRANTY, INCLUDING THE IMPLIED WARRANTY OF FITNESS FOR A PARTICULAR USE OR PURPOSE AND THE WARRANTY OF MERCHANTABILITY, IS LIMITED IN DURATION TO THE EXPRESS WARRANTY PROVIDED HEREIN UNLESS A SHORTER PERIOD IS PERMITTED BY LAW. OWENS CORNING SHALL NOT BE LIABLE FOR INCIDENTAL OR CONSEQUENTIAL DAMAGES. THIS WARRANTY CONTAINS ALL OF THE PROVISIONS OF YOUR REMEDIES FROM OWENS CORNING. OWENS CORNING'S LIABILITY IS LIMITED TO THE PROVISIONS OF THIS WARRANTY, WHETHER ANY CLAIM AGAINST IT IS BASED UPON STRICT LIABILITY, NEGLIGENCE, BREACH OF WARRANTY OR ANY OTHER LEGAL THEORY OR CAUSE OF ACTION.

Some states do not allow limitations of how long an implied warranty lasts and/or do not allow the exclusion or limitation of incidental or consequential damages, so the above limitations or exclusions may not apply to you. This warranty gives you specific legal rights and you may also have other rights that vary from state to state.

NOTIFICATION OF CLAIMS

Claims pursuant to this warranty must be submitted in writing, together with proof of purchase, to Attn: Atticat Warranty Administrator - Owens Corning, PO Box 10014, Toledo, OH 43682-4049 within 30 days after discovery of the alleged defect. Within 30 days after receipt of the Purchaser's written claim, an Owens Corning representative will contact the Purchaser to investigate the claim. At the sole discretion of Owens Corning, an Owens Corning representative may visit the site where the Atticat Machine and components are located for testing and/or examination purposes.
